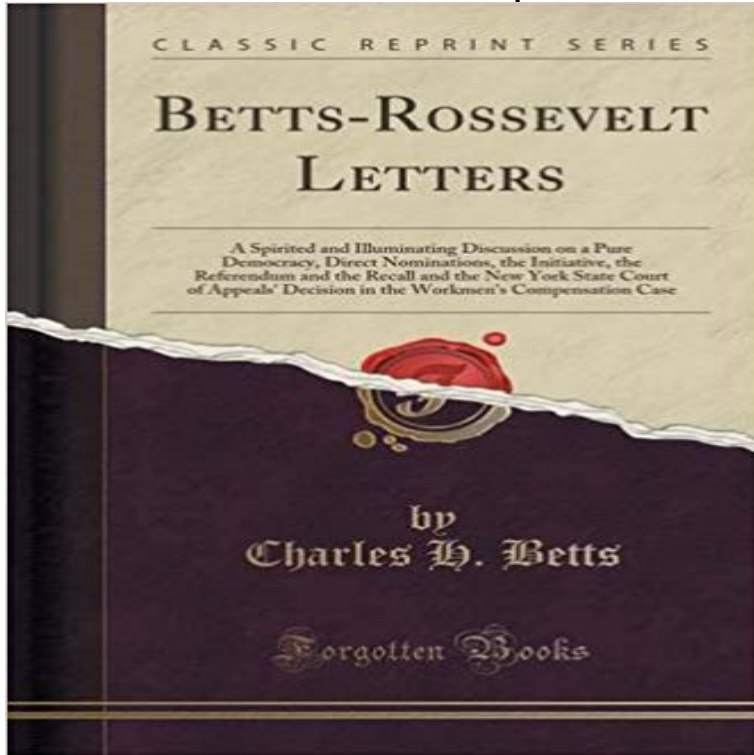

This movement is not progressive, but reactionary. It is a species of political atavism. It is a reversion to the diseases, disorders and deformities of the primitive political state. This whole movement, which is promoted largely by noise, is being carried on in blissfully ignorant disregard of the plain teachings of history and experience, and in bold defiance of the enlightened statesmanship of the civilized world. Therefore, it has been deemed wise and timely, to present to the public in this form the Betts-Roosevelt letters, which contain a somewhat spirited and illuminating discussion of this whole subject. There is so much general ignorance on this subject, - largely because there has been no systematic study of it, - that it is high time the American system of government was thoroughly discussed and its merits presented to the public in a true light. For the purpose of aiding in this necessary work, the writer has added to the Betts-Roosevelt letters a large number of quotations on this subject from philosophers, statesmen, historians, scholars and students of political science, past and present. It is his aim to marshal and present to the reader the best thoughts and conclusions of the greatest thinkers of

the world on the subject. The writer hopes that these opinions, arguments and philosophical observations will throw an added light upon our system of representative government, and he is of the opinion that those who take the trouble to read the arguments and conclusions herein presented will gain a new appreciation of the American system of representative government, so wisely founded by the fathers of the Republic, who by the universal voice of posterity are admitted to have been a galaxy of the greatest statesmen ever assembled at a given time, to frame a constitution and found a government.
