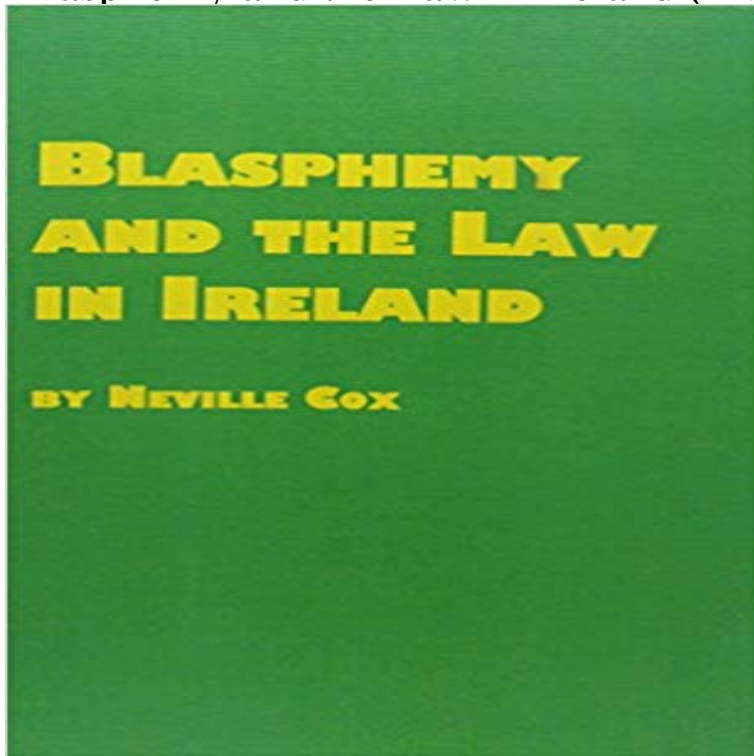


Blasphemy and the Law in Ireland (Irish Studies)
