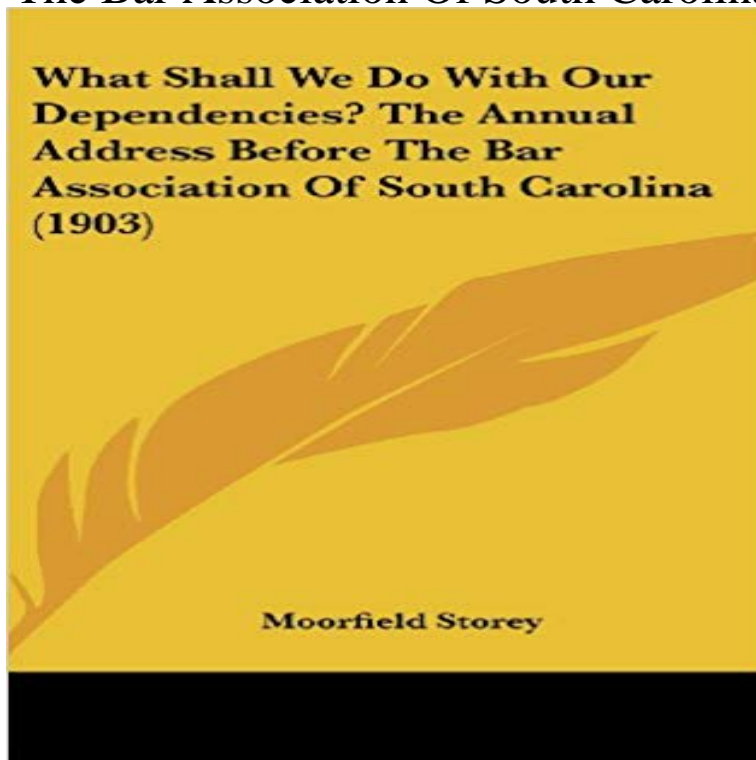


What Shall We Do With Our Dependencies? The Annual Address Before The Bar Association Of South Carolina (1903)
