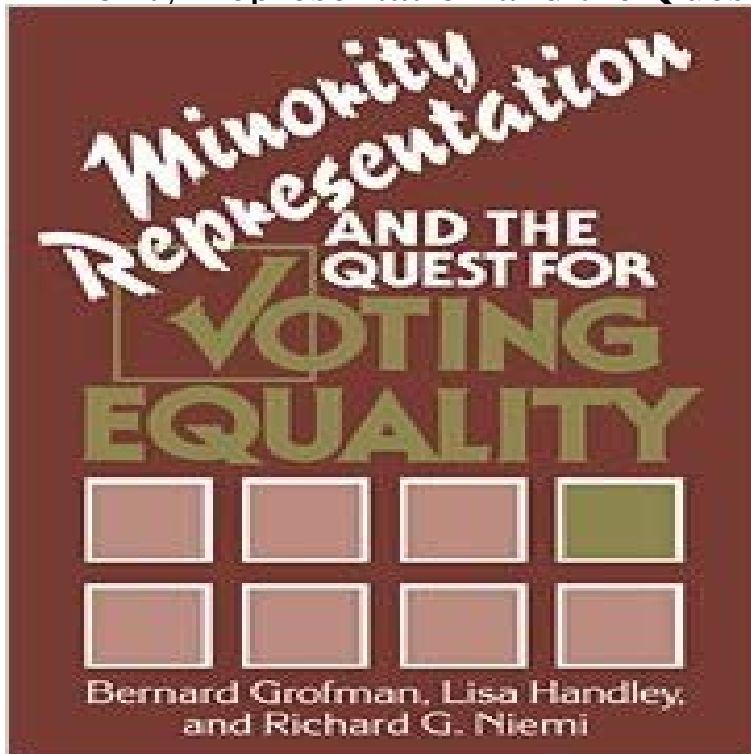


## Minority Representation and the Quest for Voting Equality
