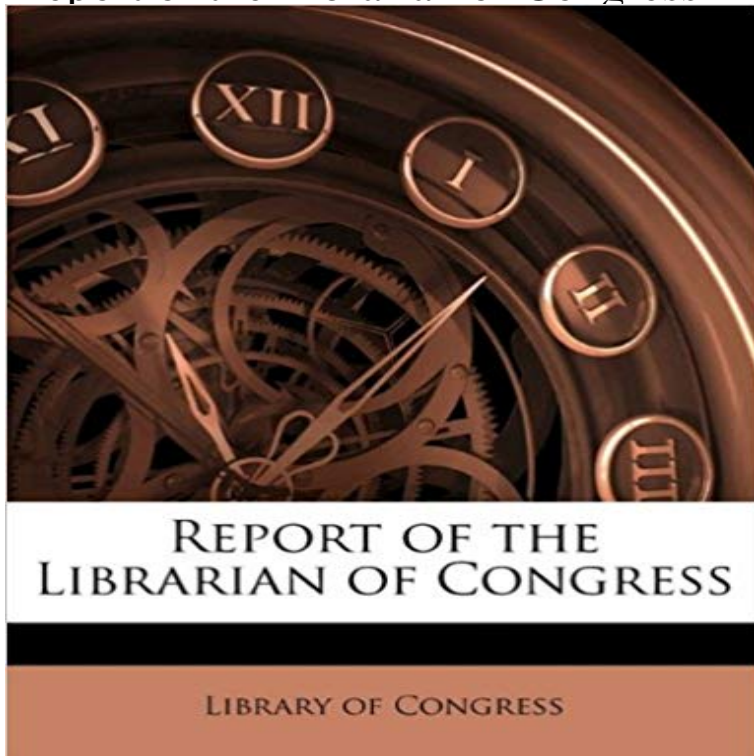


Report of the Librarian of Congress
