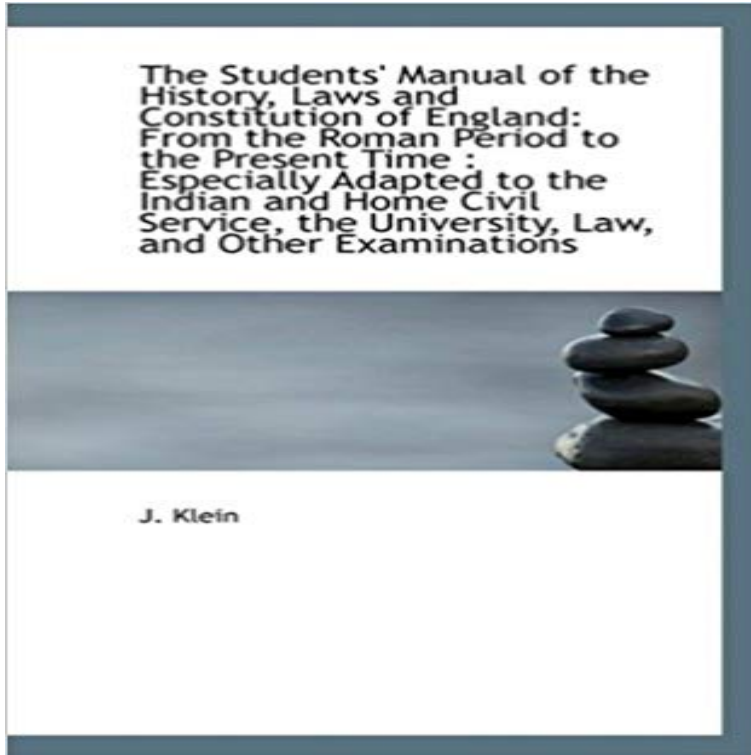


The Students Manual of the History, Laws and Constitution of England: From the Roman Period
