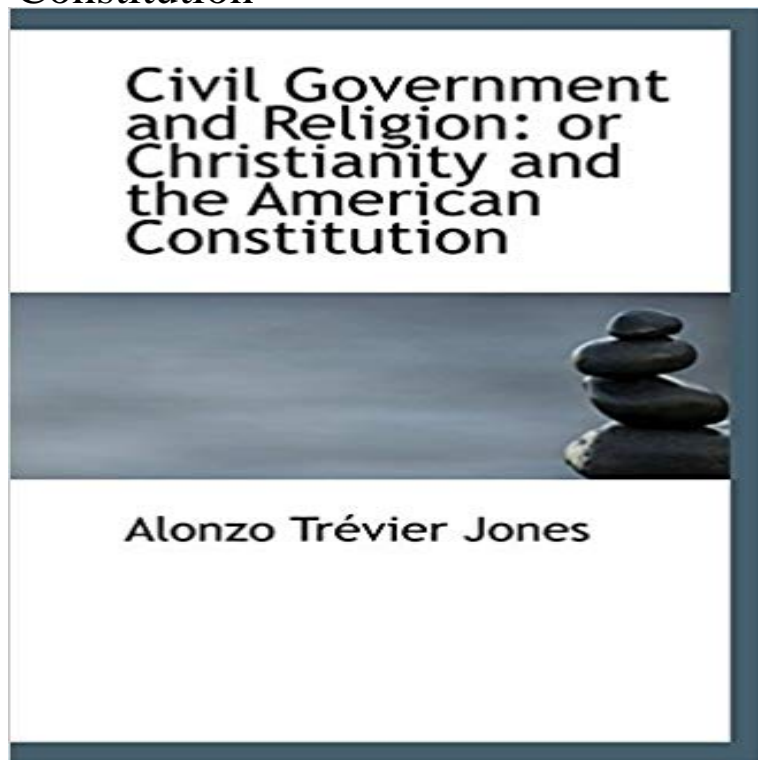


# Civil Government and Religion: or Christianity and the American Constitution
