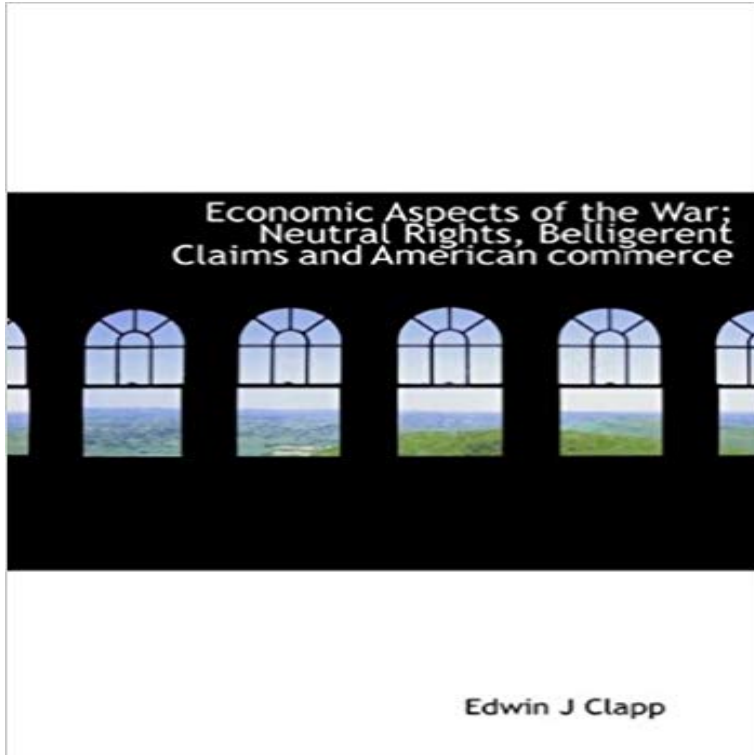


# Economic Aspects of the War; Neutral Rights, Belligerent Claims and American commerce
