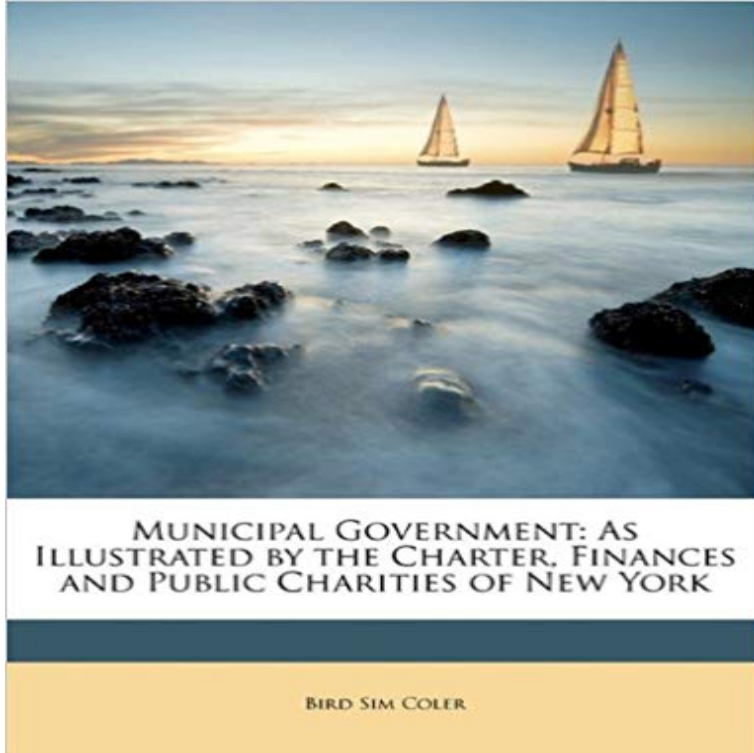


Municipal Government: As Illustrated by the Charter, Finances and Public Charities of New York
