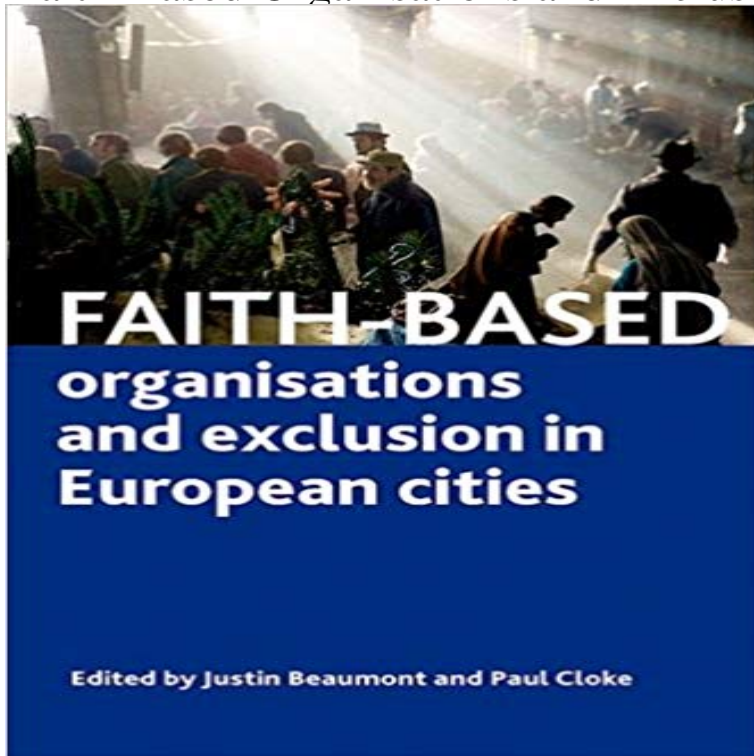


## Faith-Based Organisations and Exclusion in European Cities
