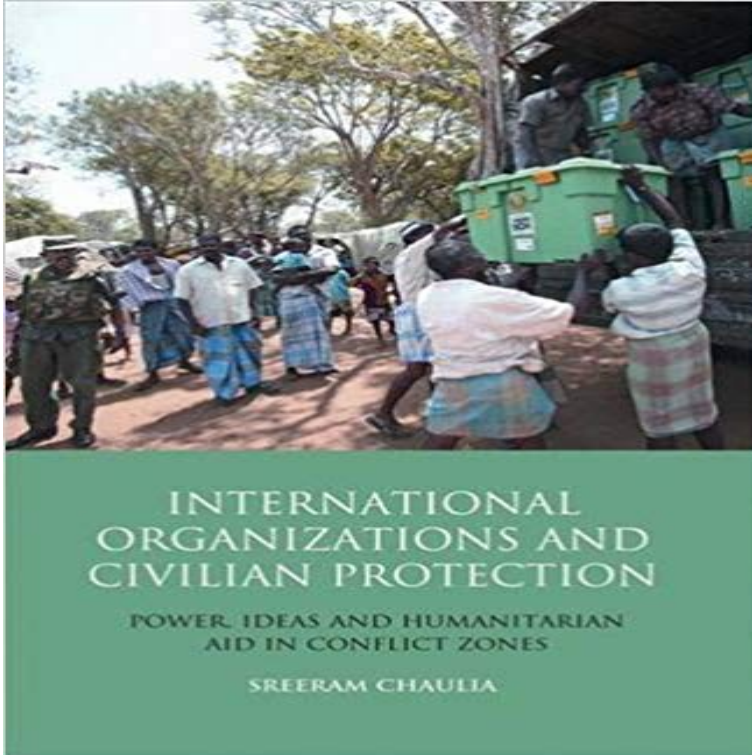


International Organizations and Civilian Protection: Power, Ideas and Humanitarian Aid in Conflict Zones (Library of International Relations)

By using a theoretical framework to examine the realities of humanitarian assistance, this analysis offers invaluable conclusions for those involved in the study of politics and international relations, as well as those concerned with practicalities of conflict resolution and peacekeeping.
