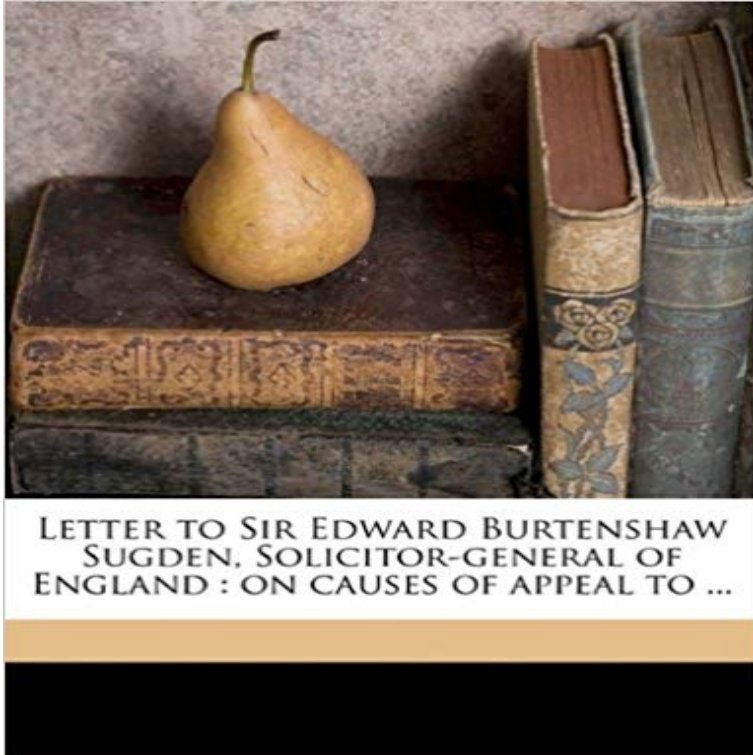


Letter to Sir Edward Burtenshaw Sugden, Solicitor-general of England: on causes of appeal to ...
