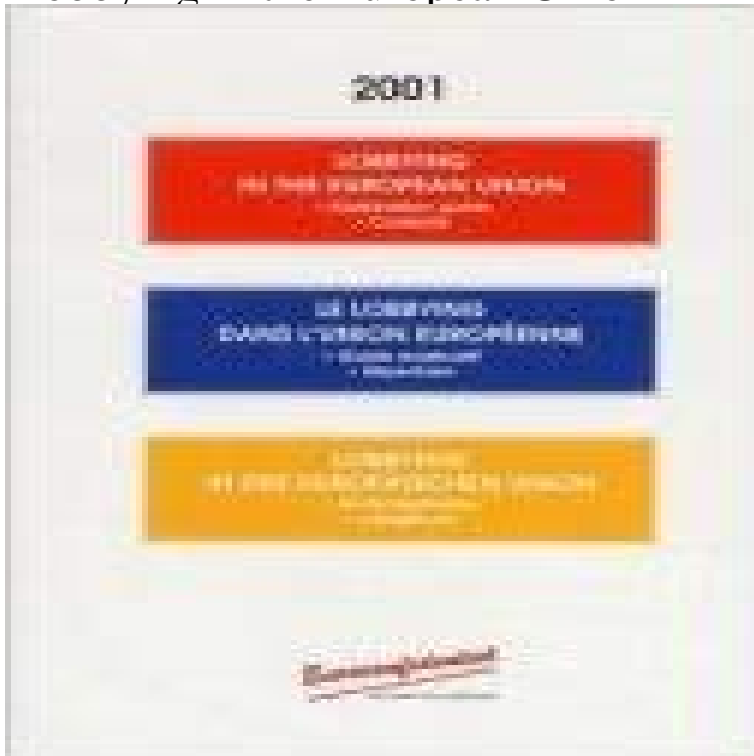


# Lobbying in the European Union
