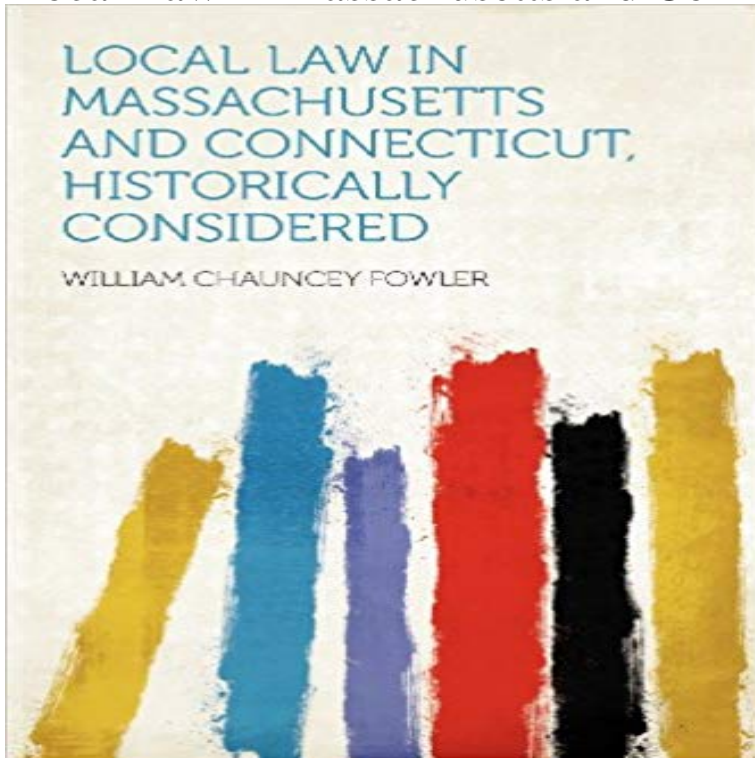


Local Law in Massachusetts and Connecticut, Historically Considered
