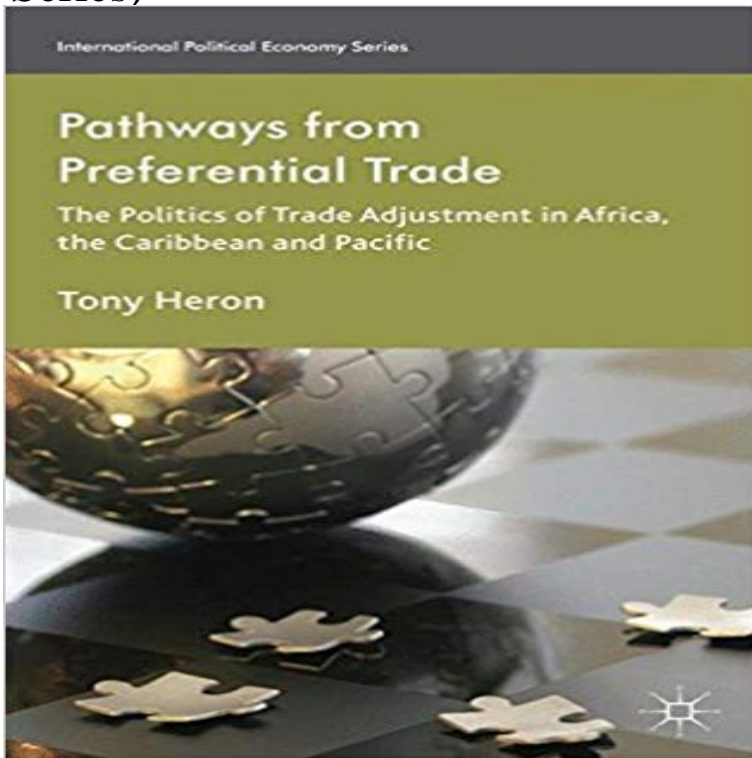


# Pathways from Preferential Trade: The Politics of Trade Adjustment in Africa, the Caribbean and Pacific (International Political Economy Series)
