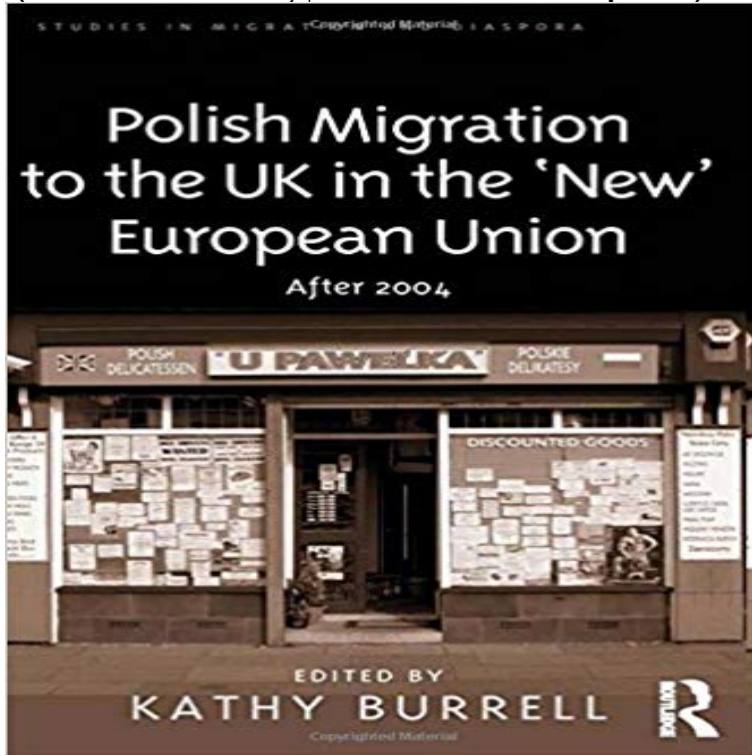


Polish Migration to the UK in the New European Union: After 2004 (Studies in Migration and Diaspora)
