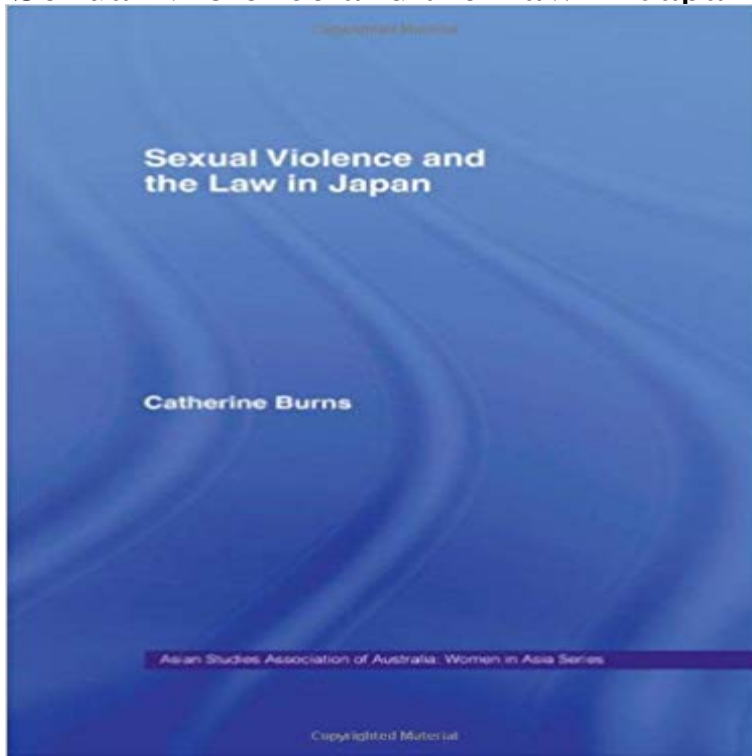


Sexual Violence and the Law in Japan (ASAA Women in Asia Series)
