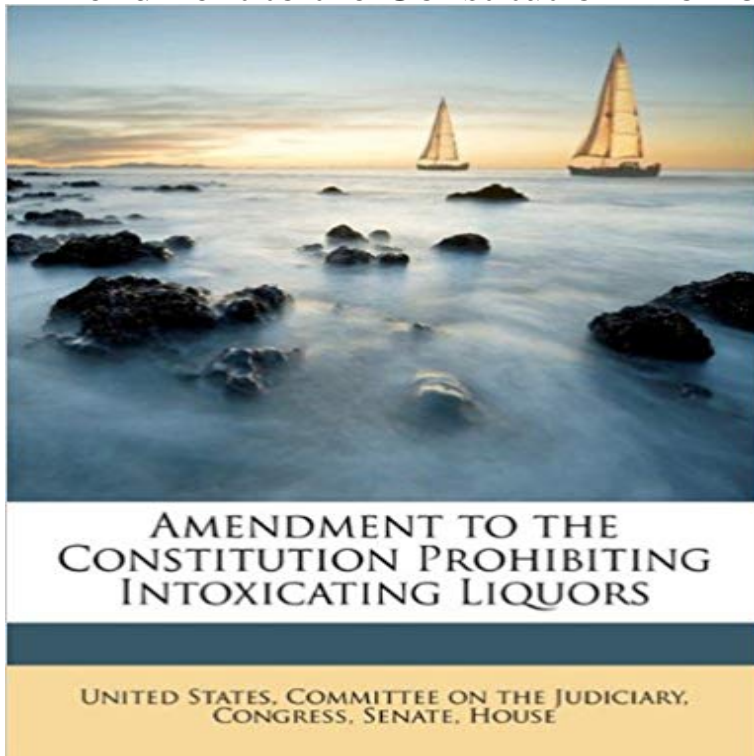


# Amendment to the Constitution Prohibiting Intoxicating Liquors
