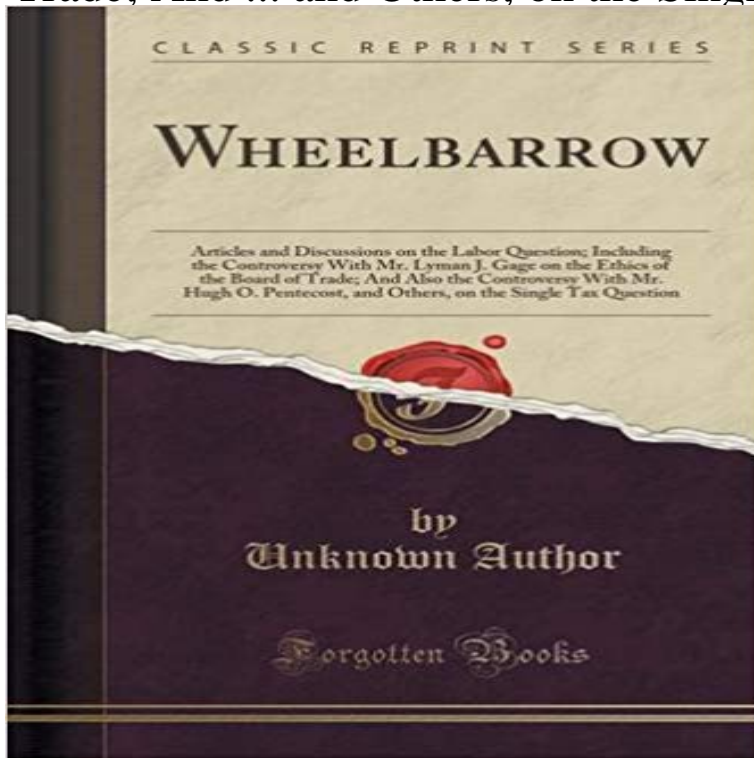

With pickaxe, shovel, and wheelbarrow he helped to lay the first foundations of several railroads in this country. So he knows from experience the sufferings and hardships workmen have to endure. His buoyant genius struggled against the odds, the restrictions, the impediments of his position; and by wisely applied exertion he grew in importance as a man, he came to the front as a character who dared to stand up for his ideals of freedom and equal right. Honors were then bestowed upon him: he was elected to represent his fellow-citizens in the legislature of his State, and in war he rose to the rank of General. He worked no longer with the wheelbarrow, but with his brains; he was powerful as an orator and wielded his pen with ability and vigor. But greater than his genius is the honesty of his aspirations, the nobility of his ideals, the broadness of his views. While aspiring to more intellectual and higher work, his sympathies with the laboring classes never waned. Wheelbarrow, however, is not a demagogue. His articles are not written in an incendiary spirit. They are sustained by a moral purport. He does not preach hatred of class and has no intention to destroy the order of society.
